ABOUT DETERMINATION OF THE EQUALIZATION  
OF THE SEMESTER CREDIT SYSTEM (CREDITS)  
OF THE FACULTY OF COMMUNICATION SCIENCE, UNIVERSITAS PADJADJARAN WITH  
THE EUROPEAN CREDIT TRANSFER SYSTEM (ECTS).

BY THE GRACE OF ALMIGHTY GOD  
DEAN OF THE FACULTY OF COMMUNICATION, UNIVERSITAS PADJADJARAN,

- Considering :
- a. that International Accreditation is a quality recognition of educational institutions by authorized agencies/organizations according to the assessment criteria of accreditation agencies;
  - b. that quality recognition from external parties includes inputs, processes, outputs, outcomes, and quality assurance systems of Higher Education;
  - c. that the government realizes the importance of the quality of higher education and the need to develop a holistic quality assurance system to improve academic quality to improve the quality standards of education, research, and services in Indonesia to be at par with International on an ongoing basis;
  - d. that based on points (a), (b), and (c) above, it is necessary to issue a Decree of the Dean of the Faculty of Communication Sciences, Universitas Padjadjaran;

DECIDING :

- Determining : DECISION OF THE DEAN OF THE FACULTY OF COMMUNICATION SCIENCE, UNIVERSITAS PADJADJARAN REGARDING THE DETERMINATION OF THE EQUALIZATION OF THE SEMESTER CREDIT SYSTEM (CREDITS) OF THE FACULTY OF COMMUNICATION SCIENCE, UNIVERSITAS PADJADJARAN WITH THE EUROPEAN CREDIT TRANSFER SYSTEM (ECTS).
- FIRST : Determining the ECTS credit score calculation at the Faculty of Communication Science, Universitas Padjadjaran is one Semester Credit Unit (SKS) equivalent to 1.8 ECTS.
- SECOND : The calculation of the determination of the equalization of this credit score can be used for students who will transfer to the Faculty of Communication Science, Universitas Padjadjaran or students of the Faculty of Communication Science, Universitas Padjadjaran who will go to the education area in Europe with the terms and conditions applied.
- THIRD : This Dean's Decree shall be effective as of the date of its enactment, provided that everything will be changed and corrected accordingly if in the future it turns out that there is an error in this determination.
